2018 Annual Report

Since 2007, moved by God's love and with the help of friends like you, JVI has rescued thousands from human trafficking and other extreme injustice. We celebrate each rescue, but in reality, rescue is only the beginning to a long road of healing, justice and restoration. Over the years, JVI has developed strong relationships with local leaders and organizations on the ground in India, Nepal, and China. Partnership is central, and enables our work to be effective, efficient, sustainable, and scalable. Together, we ensure quality and comprehensive services for survivors of slavery and other injustice – for the long haul. One example is Suresh Manjhi and his wife, Rajiya Devi, pictured here. We first met Suresh in 2014, secretly, on a dusty road in Bihar, India where he had slipped away from his work on a slave plantation to bravely share his story of abuse and oppression.



Shortly thereafter, thanks to the vigilance of JVI's staff and our local partner working closely with government officials, Suresh, Rajiya and 158 others were freed from multigenerational agricultural slavery. In Fall of 2018, we had the great privilege of meeting with Suresh, Rajiya and their two young children who were born in freedom. Four years after the rescue they are enjoying the fruits of sustained freedom, including decent jobs, education for their children, new financial assets, and a safer community where their rights are respected. This is just one of many JVI stories of freedom. Thanks to you and the dedicated work of our staff and partners, girls rescued from the sex trade are experiencing healing, mothers and fathers suffering in slums now have protection from violence and abuse, and young boys freed from forced labor slavery are enrolled in school. But there is still so much work to be done. Will you help us bring new freedom, justice and restoration?

What We've Accomplished Together:

Together, we directly impacted over **20,000** lives and thousands more were indirectly impacted through the ongoing work of our justice partners.

Together, we provided freedom, justice and restoration in **three** countries with **75+** partners through **three** key projects.



2018 Projects

SUSTAINED FREEDOM PROJECTS INDIA AND NEPAL

The goal of this project is to protect potential victims and secure sustained freedom, justice and restoration for victims of sex trafficking, bonded labor, domestic servitude, child slavery and other forms of extreme injustice through partnerships with local churches, NGO's and government officials.

To accomplish this project, JVI focused on achieving the following objectives:

- Protecting and assisting victims and prosecuting traffickers through legal casework;
- Equipping churches, local NGO's, and government officials to protect, rescue and restore victims through human rights training;
- Transforming unjust systems into systems that protect vulnerable communities through advocacy;
- Ensuring sustained freedom, justice and restoration for human trafficking survivors by strengthening the capacity of local "freedom businesses" and other justice organizations.



URBAN JUSTICE INITIATIVE INDIA

Over half of Mumbai's citizens live in oppressive and abusive slum communities. Imagine living with a family of five or more in a tiny one room shelter that has no running water or toilet, in a rat-infested neighborhood where garbage is piled on the streets and open sewers run through the area where your children play.

Human traffickers, sexual predators and other criminals thrive in this desperate, unstable environment. Taking advantage of the lack of rule of law, they prey upon the men, women, and children who live there.

To accomplish this project, JVI focused on achieving the following objectives:

- Protecting families from violence and helping them secure access to opportunity for a better life through legal action, training, advocacy, and capacity building;
- Empowering men, women, and children suffering in Mumbai and Kolkata slum communities by working with the government to improve justice systems.



CHINA ANTI-TRAFFICKING INITIATIVE

In China, JVI works with businesses and universities to support anti-trafficking research and other efforts to develop solutions to the problem of human trafficking.



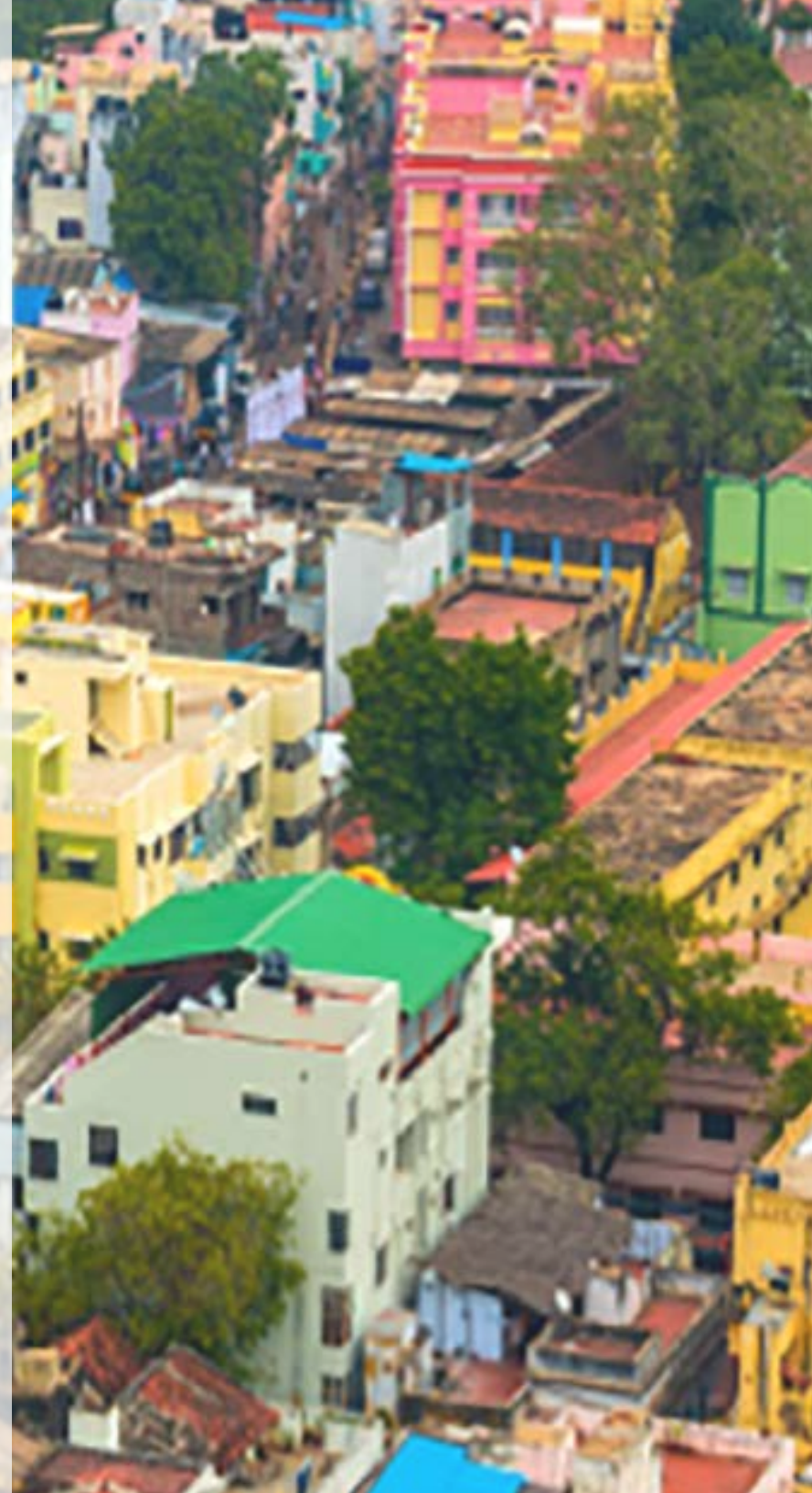
To accomplish this project, JVI focused on achieving the following objectives:

- Conducting anti-human trafficking legal research and field interviews through university partners;
- Delivering pro bono corporate legal services to support business enterprises employing women who are vulnerable to human trafficking;
- Educating stakeholders about the scope of the problem, strategies and approaches to fight human trafficking both within and outside of China by public and private actors.

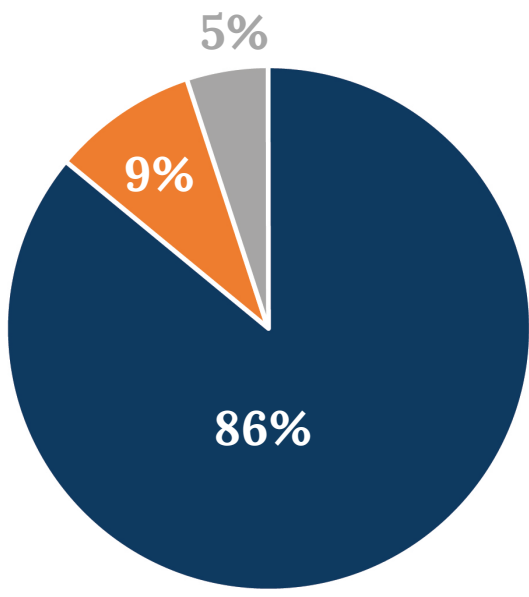

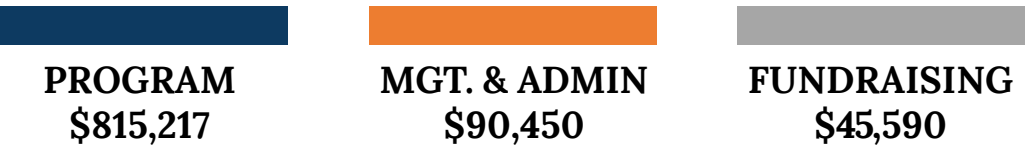

Justice Partner Interventions includes all the work our team of investigators, lawyers, aftercare workers and others do in securing justice for individual men, women and children by mentoring and working shoulder-to-shoulder with our local partners to investigate and document cases of injustice, file complaints or other legal action with local authorities, represent victims in court proceedings, and providing survivors with restoration services to ensure they remain free from slavery or other injustice.

Justice Partner Equipping and Advocacy includes all the work our team does in conducting training sessions and a range of other government relations activities with judges, prosecutors, police, labor officials, government administrators, government legal aid programs and other officials. It also includes training that we do for NGOs and businesses on effectively carrying out anti-trafficking and other justice programs and training sessions we conduct for vulnerable populations working in collaboration with government officials and/or NGO partners.
