

JVI's vision is to see unjust communities transformed into communities reflecting God's love, where the dignity and human rights of the poor are respected. JVI partners with local organizations and global stakeholders to bring freedom, justice, and restoration to men, women, and children suffering from human trafficking and other extreme injustice.

SECURING **JUSTICE** **FOR INDIVIDUALS**



87 FREE FROM BONDED LABOR IN BRICK KILN

In April, JVI and one of its local partners coordinated with police to rescue 87 survivors, representing 22 families, from forced labor slavery in a brick kiln located on the outskirts of Delhi. While these families are now free and receiving aftercare, JVI and partners continue to work for justice on their behalf through the courts and public policy reform.



HISTORIC VICTIM COMPENSATION AWARDED

JVI and legal partners secured the highest victim compensation ever awarded in India. This award was provided to Asha,* a survivor of child sex trafficking, who now is more financially able to secure her future.

JVI continued to pursue justice on her behalf through the conviction of those responsible for her enslavement. Today, Asha is enrolled in school and is undergoing vocational training for handicrafts.

143 SURVIVORS NOW HAPPY BEING FREE

In May, JVI and a local partner, along with police and authorities, coordinated a rescue intervention for 143 children, women, and men enslaved in a brick kiln. JVI's legal team is working closely with police and prosecutors to hold the traffickers accountable and secure continued freedom for the survivors as well as government rehabilitation assistance.

EMPOWERING **LOCAL PARTNERS**

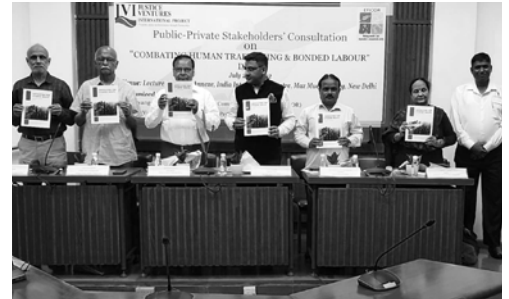

JVI builds the capacity of local nonprofits, businesses, and other organizations engaged in the work of justice by coming alongside, joining together as partners, and bolstering their effectiveness.

Duncan Hospital, a JVI lead partner, operates a JVI-sponsored Justice Hub in Bihar along the Nepal border. In March, the Justice Hub team was alerted by other staff at Duncan Hospital concerning a 15-year-old patient, who was admitted with attempted suicide. The girl, severely traumatized, expressed that she and her sister-in-law had been abused by the owner of a dance orchestra.

Through further investigation and coordination with the local Anti-Trafficking Unit, the Justice Hub team and authorities conducted a rescue operation to retrieve the sister-in-law and arrest the accused trafficker.



STRENGTHENING **JUSTICE SYSTEMS**

Supreme Court passes order securing virtual testimony for minor sex trafficking victims.

JVI works to strengthen justice systems by promoting healthy communities, while advocating for positive changes in law, policy, and practices to key stakeholders on issues of extreme injustice.

In February, the Supreme Court of India set a precedent in the fight to hold child traffickers accountable by passing an order which requires all states in India to allow for the virtual testimony of minor sex trafficking victims. This provides a safer, trauma-informed experience for children.



STRONGER **TOGETHER**

Thanks to the generosity of friends like you, we've successfully completed 45 operations this year, bringing freedom to 1,126 survivors of human trafficking.

JVI walks alongside rescued survivors for a minimum of 24 months. This year, 7,351 survivors are receiving legal aid and aftercare from JVI and our local partners. This intentional and holistic approach has allowed JVI to consistently report 85%-90% of survivors experience sustained freedom (less than 10% recidivism rate for bonded labor survivors and 15% for sex trafficking survivors).

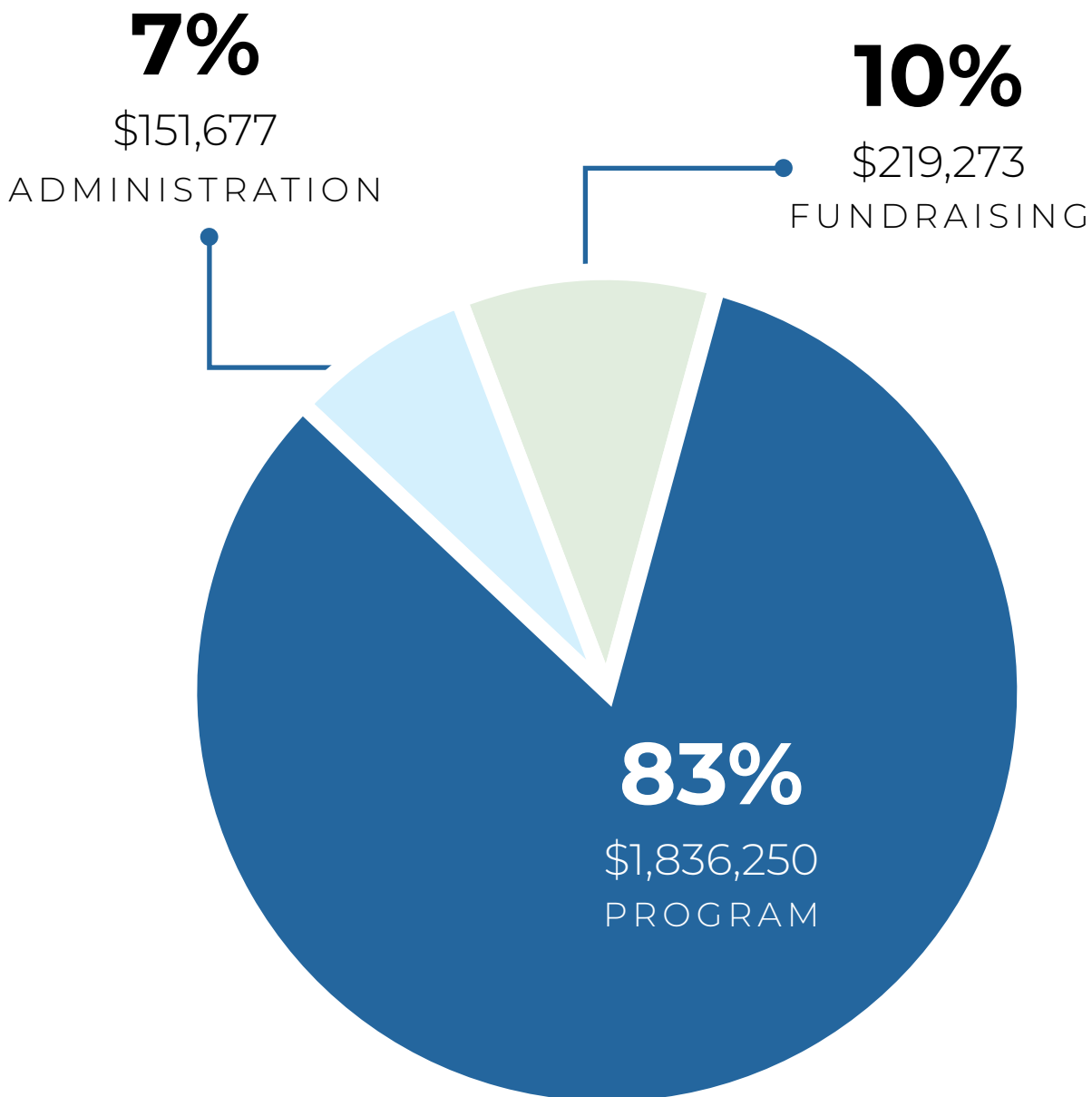
